The Monona County Board of Supervisors met in regular session at 8:30 a.m. o'clock on Tuesday, April 2, 2024 in the boardroom of the courthouse in Onawa, Monona County, Iowa with Chairman Fox presiding. Other, Supervisors present: Tom Brouillette. Supervisor Absent: Vince Phillips. Also, present were Auditor Peggy A. Rolph, Wray and Rachel Wright, Bob Steiner, Leana Shull, and Don Phipps.
