Denise Ballard and Cindy Allen, IGHCP Insurance reviewed the health insurance renewal with the Supervisors. Kelly Parsley, Deputy Auditor was also present.

Ian McConeghey, County Attorney, was present to discuss re-payment from TK Elevator. Ian will send a letter to TK Elevator requesting the county be reimbursed for payments that were made to TK Elevator when services had not been performed. No action taken.

Present for the discussion on the NEW Cooperative Port Grant opportunity were Frank Huseman and Jared Ehrp, NEW Cooperative; Brian Tapp, Iowa Area Development Group; Abby Riesberg, Treasurer; Ian McConeghey, County Attorney; Dustin Wallis, County Engineer; Tyler Wessling, Assistant to Engineer I; Zach Schrader, Assistant to Engineer II; and Jackie Schrader, county citizen.

Mr. Huseman presented the information on the Federal Grant Program opportunity to the Supervisors. As a private entity, NEW Cooperative cannot apply on their own behalf. They can apply jointly with the one following: a Port Authority, a state or political subdivision of a state or local government, an Indian Tribe, a public agency or chartered authority established by one or more states, or a special purpose district with a transportation function. The grants may be used for capital projects to improve the safety, efficiency, or reliability of the loading and unloading of goods at the port, such as for marine terminal equipment. The movement of goods into, out of, around, or within a port, highway or infrastructure, operational improvements, including projects to improve port resilience, or the purchase of cargo handling equipment and related infrastructure. The federal funding would be 80% with NEW Cooperative funding the other 20%. NEW Cooperative would like to apply for funding for project costs of approximately 8 to 10 million dollars and would like Monona County to be the applicant on their behalf. The County would be the clearinghouse. The grant money would essentially flow through the county with the County being reimbursed for administrative services. The deadline to apply for the grant is April 28, 2023.
